I hereby certify that I have read the Eligibility Criteria and acknowledge the General treatment of the procedures.

Acknowledgment 確認

1. I may not be eligible for Streamlined Filing Compliance Procedures.
我可能沒有資格參與簡易遵從程序。
2. I will be asked to certify that my failure to report is non-willful.
我將會被要求簽證缺報係非蓄意所為。
3. I will be subject to penalties if I do not qualify as residing outside the U.S.
我將會有罰款，如果無法符合居住於美國之外的條件。
4. The IRS Criminal Investigation Division will examine my submission.
我繳交的資料會受到刑事單位的檢驗。
5. My submission may not be accepted.
我繳交的資料可能不被接受。
6. My submission may be subject to an IRS audit as a normal tax return.
我繳交的資料可能會有像一般稅單的查稅。
7. I will be expected to comply with U.S. law in all future years and to file returns in accordance with regular filing procedures.

12. I may owe tax and will be asked to pay it, along with any interest.

13. I will be asked to pay the invoice before each section of the process.

我將會被要求在每一個階段開始之前付款。

14. Payment shall be made with U.S. currency.

15. I will be responsible for the accuracy of the information and will be required to review all materials.

我將會要對資料的正確負責，並且必須校對檢查資料。

Eligibility Criteria, 參與資格

1. Only for individual taxpayers, including the estates of individual taxpayers.

只有自然人納稅人及自然人的遺產可參加。

2. The program differs for taxpayers residing outside the United States.

- a. Taxpayers were residing outside the United States,

- i. Meet the applicable non-residency requirement.

- ii. Failed to report the income from a foreign financial asset.

- iii. Failed to pay tax on the income from a foreign financial asset.

- iv. Failed to report a foreign financial asset.

b. Taxpayers were residing in the United States,

i. Fail to meet the applicable non-residency requirement.

ii. Had previously filed a U.S. tax return.

iii. Failed to report the income from a foreign financial asset

iv. Failed to pay tax on the income from a foreign financial asset.

v. Failed to report a foreign financial asset.

3. The asset that was not reported will be subjected to the 5% miscellaneous offshore penalty.

未申報的海外帳戶資產總額的 5% 的雜項海外罰款。

4. Taxpayers must certify that the conduct was not willful.

納稅人必須保證缺報行為係非蓄意為之。

5. IRS has not initiated a civil examination of the taxpayer's returns for any taxable year.

納稅人不在 IRS 民事調查中。

6. IRS has not initiated a criminal investigation of taxpayers' returns for any taxable year.

納稅人不在 IRS 刑事調查中。

7. Taxpayers eligible to use streamlined procedures who have previously filed delinquent or amended returns must pay any previously assessed penalties.

納稅人先前申報時產生的罰金仍然要繳納，即使納稅人合格於簡易遵從程序。

8. Taxpayers who want to participate in the streamlined procedures need a valid Taxpayer Identification Number.

納稅人必須要有 SSN 社會安全號碼或 ITIN 稅號。

General treatment 一般處理

1. Processed like any other return submitted to the IRS.

申報後的處理和一般報稅相同。

2. Will not automatically be subject to an IRS audit.

不會自動引起查稅。

3. May be selected for audit under the existing audit selection processes.

有可能按一般選取原則查稅。

4. Will be expected to comply with U.S. law in all future years and to file returns in accordance with regular filing procedures.

未來會守法申報。

5. Coordination between streamlined procedures and OVDP

簡易遵從程序和 OVDP 海外稅務自首計畫

6. OVDP or streamlined procedures

如果納稅人的缺報行為係蓄意為之，必須走 OVDP 海外稅務自首計畫以免刑事究責。

7. May not participate in OVDP.

簡易遵從程序後不得再參加 OVDP 海外稅務自首計畫。反之亦然。

8. May request treatment under the applicable penalty terms available under the streamlined procedures.

如果 OVDP 還沒有執行最後協議，可能可以按簡易遵從程序來處罰。
